## Q&A session with Tom Copeland

After hearing from many of our own providers about their concerns related to ARPA funds, the ELRC invited Tom Copeland, a leading expert in the business of family childcare, to join us for a Q & A session related to the ARPA grant. Over 100 providers from Regions 11, 12, 13, 14 & 16 joined the call to ask questions regarding tax implications and spending of the ARPA funds. This was an informative session that addressed many provider concerns and helped administrators plan for the receipt and spending of these funds. ## Region 13 Provider Supports

In January, the Berks and Schuylkill Director's Networks combined to form one Director's Network for our region. The group discussed strategies to capture experience in the classroom to meet DHS requirements for staff and group supervisors. Quality Coaches provided an overview of completing a Staffing Profile, and how it relates to the Staff Qualification tool when looking at earning points for STAR 3 and STAR 4. ## ELRC Updates

## American Rescue Plan Act (ARPA)

ARPA Grant applications were due to the ELRC by January 31, 2022. The applications received in January continue to be processed.

Grant monitoring will take place in the summer of 2022 so it is important to keep receipts organized. Begin to track expenses into these categories:

- Personnel costs
- Rent/Mortgage & Utilities
- Facilities Maintenance & Insurance
- PPE, Cleaning & Health & Safety Practices
- Equipment & Supplies
- Goods & Services
- Mental Health Supports for Staff & Children

Providers will receive 6 installments for the ARPA grant. Your last payment will be 6 months from the date of your first payment. Payments are scheduled to be released via direct deposit or paper check on the following dates:

- 2/22/22
- 3/22/22
- 4/22/22
- 5/20/22
- 6/22/22



## CCW Updates

- **Non-traditional Add-on** - Effective 1/1/22, a 25% add-on rate will be paid for a child who receives at least 2 hours of care during non-traditional hours on a weekday or any care received on the weekend. Please check your invoices to be sure schedules are correct
- **Co-pay decreases** - Effective 1/17/22, most families enrolled through CCW have been issued a co-pay decrease. Providers should have received an updated enrollment summary for all affected families. Email [elrc13@cscinc.org](mailto:elrc13@cscinc.org) with any questions or concerns.

## CCW Payments - Virtual Learning

If a school district moves to virtual learning due to COVID and a child will now be in care full-time, providers will be paid full-time as long as they have accepted the blended rate.

- Please mark these children as FT on your invoice.
- Please note this does not include closures due to weather, school holidays, etc. These days are already covered by your blended rate.

## STARS Movement Tip of the Month - Family Resource List

Keystone STAR indicator FC3.4.7 requires providers to have a current community resource handbook. This resource list should be reviewed annually and updated with the most current information. Agencies you may include could be



CHIP, local food banks, Intermediate Units, Early Intervention, school districts and local health care providers. Review your list to ensure that it now includes the ELRC (not CCIS!).

## Child Health Advocate Course

Enrollment is now open for the Spring 2022 **online** Child Care Health Advocate course (EARL 160-01) offered by Northampton Community College. This unique 3 credit college course is taught remotely over 10 weeks (February 24 - May 11, 2022). The course addresses 15 different health and safety modules as a resource for child care directors, teachers, assistant teachers, and child care practitioners. OCDEL will cover all tuition-related fees (valued at over \$1000); books and materials are the responsibility of the student.

## COVID Guidance

### Return to Work or Care

A PA specific requirement is that to return to work or care, the individual must provide a written note OR a negative test result signed and verified by a physician or nurse practitioner clearing them to return to the child care facility.

Also acceptable, is a negative test result signed by a pharmacist testing site operating with CLIA Certificate of Waiver or Certificates of CLIA Compliance, such as a CVS or Minute Clinic, if they are unable to have their pediatrician provide a written note or a signed negative test result.

### COVID Exposures & Quarantine

COVID guidance has been confusing and causing difficulties for providers to follow proper quarantine and return guidance. OCDEL refers programs to follow [CDC Guidance for Childcare](#) for the most up to date recommendations.
