# ELRC Updates

## CCW Reminders

- Watch for the enrollment summaries with copay changes for most families effective 5/1/23.
- You should have received information regarding the Appendix B - Provider Closures for 2023-2024. Please reach out to your provider specialist with any questions.
- Watch for the school-age summer enrollment request to come to your email the first week of May.

## The Importance of Record Keeping

Maintaining accurate and up to date attendance records is a requirement of your participation in the Child Care Works program. The ELRC may solicit your private attendance records at any time for a variety of reasons. Common instances of this include OSIG referrals, excessive use of “No Change” on CCW invoices, and as evidence for parent appeals of absences. Please see below for a reminder of the conditions that are outlined in Article III of your ELRC Provider Agreement.

## Requirements for Keeping Information

The provider must keep the information listed below for a minimum of six (6) years after the end of the fiscal year that child care was provided, or until audits, legal actions, claims or other disagreements with the ELRC and/or OCDEL are resolved, whichever is later:

- i) Attendance sheets, which include attendance invoices and daily attendance logs. The daily logs are required either in electronic or a hard copy and must show each child's name, drop-off and pick-up times, and date. Each drop-off and pick-up must be validated by the parent with signatures or an electronic sign in/sign out process;*
- ii) Financial records;*
- iii) Documents required for this Agreement;*
- iv) Documentation of actions taken by OCDEL against the provider;*
- v) Information that relates to the settlement of claims arising out of the performance or amount of money paid under this Agreement; and*
- vi) Any other information required for this Agreement.*

## Work Force Support 2.0

All staff retention funds must have been paid out to the staff within 45 days of receipt.

- These funds must be paid out in one lump amount
- Must be paid through payroll



Staff recruitment funds are to be used on expenses between 7/1/22-6/30/23. Please see your grant application for eligible expenses.

Applicants may apply for up to \$15,000 in funding.



## It's Time to Revisit Your Supervision Policy for Summer!

Summer will be here before we know it and you are probably busy working on your summer programming schedule. You may be hiring additional staff, planning field trips or tweaking your playground schedule. The most important aspect of your summer planning is to ensure that all of your staff understand and implement your supervision policy.

As per Certification's regulation, "Each staff person shall be assigned the responsibility of specific children. The staff person shall know the names and whereabouts of a child in his/her assigned group. Children on the facility premises or facility excursions shall be supervised by a staff person at all times."

As part of your summer planning, revisit your supervision policy with all of your staff. As you observe each classroom, ensure that your staff are counting children before and after using the playground, taking walks or going on field trips. Ensure every staff knows which children they are responsible for and that they know the children's names. In addition, ensure that all staff are in ratio with their age group.

Summer programming is challenging and requires daily adjustments to cover staff's vacations, increased enrollments and special events or excursions. If you are hiring new staff or floaters for summer, ensure they know which children they are responsible for and that they know each child's name, especially if they are covering multiple classrooms or age groups throughout the day.

It is up to you to ensure your staff understands and implements your supervision policy. Provide your staff with attendance charts, clipboards or software tool they need to track the children they are responsible for each day. Create a safe and healthy summer program by planning and working together to keep all children safe!

# Health & Safety

## Free Carbon Monoxide Detectors

If you're a Pennsylvania certified childcare provider, you are eligible to receive two complimentary Carbon Monoxide Detectors. OCDEL is making these detectors available, but the ordering and placement of detectors is not a regulatory requirement.

## Medicaid and CHIP Renewals

Starting April 1, 2023, Pennsylvania is required by federal law to review Medicaid and CHIP recipients' eligibility every year, which means that recipients must submit a renewal.

It is very important that renewal forms are completed and returned even if nothing has changed. Completing a renewal allows DHS to determine eligibility for MA or CHIP coverage. Coverage will continue for recipients who are still eligible.

There are a few ways for recipients to complete a renewal:

- Complete the forms DHS sends and mail them back in the envelope included in the packet.
- Drop completed forms off at the [local county assistance office \(CAO\)](#).
- Complete the renewal online at [dhs.pa.gov/COMPASS](https://dhs.pa.gov/COMPASS).
- Complete the renewal over the phone by calling 1-866-550-4355.

Make sure contact information is correct with DHS. Recipients can opt-in to receive text messages and email alerts about their benefits.

## Opportunity for a Device that Cleans Air & Sanitizes Surfaces of Viruses, Bacteria & Mold

The Pennsylvania Department of Health is currently evaluating devices that can eliminate viruses, bacteria, mold and other pathogens from air and surfaces, simultaneously. The devices could be stand alone or wall mounted, utilize a standard outlet for power, and would come with two years of supplies that may be needed to run the device. If funding is approved, DOH would purchase and distribute the devices free of charge to small businesses, non-profit entities,

child care and other facilities throughout the Commonwealth to mitigate the spread of COVID-19, flu, and other diseases.

## Oral Health

### First Aid for a Child's Oral Injuries

Injuries to the head, face, and mouth are common in young children. Even when adults do their best to keep children safe, oral injuries can happen. Most oral injuries happen when young children are learning to walk. The top front teeth are injured most often. Check out this [flyer](#) and the tips below for more information.

#### Tips to help you know what to do for common oral injuries:

- Tongue or lip injured. Clean the injured area. Press a clean washcloth on it to stop bleeding. Keep the child's head up and facing forward to prevent choking. Put ice, wrapped in a clean washcloth, on the area to reduce swelling. If bleeding doesn't stop after 30 minutes, the child should be taken to see a dentist or doctor right away. If the dentist or doctor is not available, the child should be taken to the nearest urgent care center.
  - Tooth chipped or cracked. Clean the injured area. The child's dentist or an urgent care center should be contacted right away. Have the child rinse with water, if possible. If there is bleeding, press a clean washcloth on the gum around the tooth to stop it.
  - Tooth knocked out. The child's dentist should be contacted right away. Do not try to put a baby tooth back into the mouth. Clean the injured area. If there is bleeding, have the child bite on the area with a clean washcloth for 15 to 30 minutes to stop it.
  - Tooth knocked loose, moved, or pushed into gum. If a child's tooth has been knocked loose, moved forward or backward, or pushed into the gum, the child's dentist or an urgent care center should be contacted right away. Have the child rinse with water, if possible. Press a clean washcloth on the gum around the tooth to stop bleeding.
  - Toothache. If a child has a toothache, it is likely that the tooth has a cavity. The child needs a dental appointment as soon as possible to find out what the problem is and get treatment.
