Reporting New Enrollments and Accurately Completing Attendance Invoicing

Please remember when accepting new children who have Child Care Works funding, if you have not already received a call from the ELRC or an enrollment summary authorizing care, please have the parents contact their ELRC Family Specialist regarding the new enrollment. The ELRC Family Specialist will then contact you to verify the enrollment and send out the enrollment summary documenting their authorized schedule and family copay. You should not accept any new enrollments until you hear from the ELRC and are sure they have CCW funding. Once you have heard from the ELRC and the child has started care, if the child does not appear on your attendance invoice for the month you must add the child to your invoice and document their start date, days they attended and absences for the month. If the child is not added to the invoice the ELRC may not be able to go back more than 30 days from the date we are notified of the enrollment to pay for services which will result in the parent having to pay privately from the time of enrollment until the ELRC payment begins.

It is very important that you review your attendance invoice each month to ensure all children are listed and that you mark the attendance invoice correctly documenting all absences or terminations of enrollment. As stated in Appendix A of the Provider Agreement, "The ELRC may audit providers who utilize the No Change code on a regular basis when completing Attendance Invoices. Noncompliance with accurate completion of Attendance Invoices may lead to termination of the Agreement and referral to the OSIG for fraud investigation."

Continuous Quality Improvement Grant

Eligible STAR 2, 3 and 4 providers who applied for the Continuous Quality Improvement Grant, received their payment in March.

It is required that you account for the spending of these award dollars. Keep all receipts for eligible expenses, including payroll records to verify staff bonuses have been paid through payroll and taxes deducted appropriately. All expenses must have occurred from July 1, 2023 - May 8, 2024

Please read through the ELRC Policy Communication and FAQ document for full

grant details and schedule a meeting with your Quality Coach to complete your Final Expense Report. Final Expense Reports are due to the ELRC no later than May 15, 2024. Any unspent funds must be returned by May 31, 2024.

CCW Reminders

- Watch for the enrollment summaries with any copay changes for families effective 5/6/24.
- Watch for the school-age summer enrollment request to come to your email the first week of May.
- Reminder to reach out to the ELRC before enrolling children with CCW funding to confirm all information.

Reporting Inability to Meet Child Care Needs



Please remember, you must notify your Provider Specialist if you are unable to provide care, for any reason, for a

child(ren) enrolled through CCW. If you are unable to meet a child(ren)'s authorized enrollment schedule due to staffing, behavior issues or any other reason, you must report it immediately to your Provider Specialist so, the child(ren) do not accrue absences and you are paid correctly. If you find it necessary to close your facility due to staffing or other emergency, you must report this immediately or within three days of reopening. If eligible, you may be able to request a paid closure(s). Your Provider Specialist is available to answer your questions.

Provider Closed Days

Providers received a request on April 18th to submit the Appendix B, Closed Days, for the 2024-2025 fiscal year. The subsidy program will pay up to 15 closed days per year from July 1, 2024, to June 30, 2025, if the provider also charges private-pay clients for the closed days listed.



It's Time to Revisit Your Supervision Policy for Summer!

Summer will be here before we know it and you are probably busy working on your summer programming schedule. You may be hiring additional staff, planning field trips or tweaking your playground schedule. The most important aspect of your summer planning is to ensure that all of your staff understand and implement your supervision policy. As per Certification's regulation, "Each staff person shall be assigned the responsibility of specific children. The staff person shall know the names and whereabouts of a child in his/her assigned group. Children on the facility premises or facility excursions shall be supervised by a staff person at all times."

As part of your summer planning, revisit your supervision policy with all of your staff. As you observe each classroom, ensure that your staff are counting children before and after using the playground, taking walks or going on field trips. Ensure every staff knows which children they are responsible for and that they know the children's names. In addition, ensure that all staff are in ratio with their age group.

Summer programming is challenging and requires daily adjustments to cover staff's vacations, increased enrollments and special events or excursions. If you are hiring new staff or floaters for summer, ensure they know which children they are responsible for and that they know each child's name, especially if they are covering multiple classrooms or age groups throughout the day.

It is up to you to ensure your staff understands and implements your supervision policy. Provide your staff with attendance charts, clipboards or software tool they need to track the children they are responsible for each day. Create a safe and healthy summer program by planning and working together to keep all children safe!

Oral Health - The Importance of Fluoride
