Taking on the Childcare Crisis

Recently, Denise Baney, Executive Director at Danville Child Development Center, joined community, business, and nonprofit leaders and welcomed Senator Lynda Culver to shine a light on Pennsylvania's growing childcare teacher shortage.

They got together to bring attention to the teacher shortage and why it is happening. Here are some of the facts shared on their <u>Facebook page</u>:

- 81% of PA employers struggle to hire or retain workers due to childcare issues.
- The shortage costs our economy \$6.65 billion each year in lost productivity and revenue.
- 83% of voters support increased state funding to fix this.
- 98% of PA voters believe early care and education is important to helping lead healthy and productive lives.

Additionally, they are calling on lawmakers to support Governor Shapiro's proposal for \$55 million in recurring funding, including \$1,000 per educator, to recruit, retain, and respect the people who care for our youngest learners. They highlighted that when we lose teachers:

- Children lose stability
- Families lose options
- Businesses lose workers
- Communities lose strength

Rapid Response Team

The Rapid Response Team provides prompt support in the event a child is at risk of suspension or expulsion. It is a short-term, collaborative approach, designed to connect families and providers with existing tools and resources. Supports are customized to fit a child's or teacher's needs.



Requests can be made using this <u>RRT Referral form</u>. Referrals are processed on a first come, first served basis and we ask that providers prioritize one child referral at a time. One of the goals of the RRT is that strategies and supports will be used across classrooms at the provider so that all children and staff will benefit from these supports.

Before submitting a referral, please discuss with the parent as parental consent is required. Child observations, screenings, and parent conferences should also have been completed so that you can provide the referral coordinator with detailed information regarding the case.

CCW Reminders

Outstanding Invoices

Providers must submit all outstanding invoices for May and June no later than <u>July 15th</u>. While other months allow for a 60-day window to submit invoices, due to the close of the FLPC fiscal year.



invoices, due to the close of the ELRC fiscal year, all invoices must be received by 7/15. <u>Invoices received beyond 15th will not be paid</u>.

School Age Flip

The School Age Flip occurred on June 16. As a reminder, providers who have

accepted the blended rate have been paid a higher part-time rate which includes 25 full-time days throughout the school year. This accounts for any gaps that may have occurred between your local school district end date and school age flip date.

Adverse Action Notification

When a family has become ineligible to continue with CCW funding, an Adverse Action (AA) is issued. Providers will also receive a copy of the AA. Please confirm receipt of this AA notification with the family and discuss next steps with them. You must wait to take action (change in fee collection, ending care, etc.) until the date on the notice, not the date the notice was received.



Keystone STARS Tip of the Month STAR Movement



Summer months bring a good opportunity to focus on some goals you may have set for yourself over the school year. College students are back to help out, attendance can be lower with family vacations and older age groups are out of



the facility taking part in fun field trips and excursions.

Use this time to work on your ERS self-assessments, begin organizing child files for the Fall, schedule staff to take some trainings on assessment tools or curriculum. If you set a goal to achieve the next STAR level this year, reach out to your Quality Coach who can help you access tools and resources to make the movement process smoother for you. Higher STAR level programs are able to receive a higher subsidy reimbursement amount, called a STAR add-on and may be eligible for higher grant amounts when grants become available this school year.

Provider Support Line

Tick Safety


What should childcare providers do when they find a tick on a child?

Department of Human Services Certification recommends that if a childcare provider finds an embedded tick, they should immediately contact the child's parent or guardian so that next steps can be determined quickly. This is

consistent with regulation 132(a). It is advised that a provider does not remove a tick unless there is written authorization by the parent and the provider has received the appropriate health and safety training to do so. Following proper technique for tick removal can be challenging; even with proper technique, heads can stay attached and need to be dug out, which can be difficult.

Summer Safety -Preventing Hot Car Deaths

Warm sunny days in the summer are the best part of the season. However, with the warm temperature comes hot cars. An average of 38 deaths per year are due to a child being left in a hot car.



Did you know

- On an 80-degree day the car's temperature can reach 107 within twenty minutes and 123 degrees after an hour
- 25% of the children entered the vehicle on their own and became trapped
- 55% of deaths occur because a caregiver unknowingly left a child in a car
- Heatstroke sets in with a bodily temperature of 104
- Bodily temperatures of 107 can be fatal

How to avoid hot car deaths

- Make it a habit to check the backseat of the car before locking it
- Leave a personal item in the backseat with the child such as a purse or briefcase
- Providers can call to check when a child doesn't show up to the center when scheduled
- Make sure cars are locked when not in use and keys are out of reach of children

The Impact of Stress on Oral Health

Stress is a reaction to a physical, psychological, or emotional demand. Everyone has felt stress at one time or another. Some stress is good because it pushes us to do things that are challenging and meet the demands of daily life. However, too much stress is not good and can have negative short and long-term effects on our health, including our oral health.



Long-term stress can cause problems with your mouth, teeth, and gums. These problems can include:

- Sores in or around the mouth.
- Teeth clenching and grinding.
- Tooth decay and gum disease.

Tips for Managing Stress:

- Eat healthy foods
- Take care of your mouth
- Seek treatment for unhealthy habits



- Practice relaxation techniques
- Talk to someone
