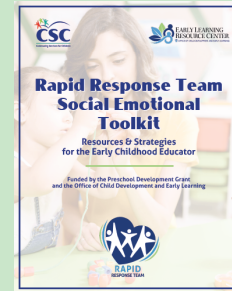
staff are already pulling documents from the toolkit to use in their classrooms to help to prevent challenging behaviors."

Rapid Response Team Toolkit Free Professional Development

****Update for the Rapid Response Team****

Region 14 is working in partnership with Glenn Koch & Associates, introducing a licensed mental health professional to our Rapid Response Team. This collaboration will provide a more comprehensive support to children and families.



The Rapid Response Team provides prompt support in the event a child is at risk of suspension or expulsion. It is a short-term, collaborative approach, designed to connect families and providers with existing tools and resources. Supports are customized to fit a child's or teacher's needs.

Requests can be made using this [RRT Referral form](#). Referrals are processed on a first come, first served basis and we ask that providers prioritize one child referral at a time. One of the goals of the RRT is that strategies and supports will be used across classrooms at the provider so that all children and staff will benefit from these supports.

Before submitting a referral, please discuss with the parent as parental consent is required. Child observations, screenings, and parent conferences should also have been completed so that you can provide the referral coordinator with detailed information regarding the case.

National Provider Appreciation Day - May 8th

CCW Reminders

Closed Days

The subsidy program will pay up to 15 closed days per year from July 1, 2026, to June 30, 2027, if the provider also charges private-pay clients for the closed days listed. The ELRC will not pay a provider for more than 15 closed days for any reason during a fiscal year. PSS users must update their closed days on PSS. Providers who do not use PSS, please complete the [Appendix B](#) indicating any closed days for **July 1, 2026 to June 30, 2027**. New Enrollments

Please remember to contact your Family Specialist when you have a new CCW child enroll in your program. The ELRC will not be able to enroll a child in your facility until confirmation has been received from you. Failure to confirm enrollment and start date will delay payments.

Child Care Staff Retention & Recruitment Grant - FER

All CCSRR grant requests have been paid out to providers.

Policy Reminders:

- Providers must pay retention awards to staff within 45 days of receipt of payment from the ELRC.
- Awards must be paid through payroll with appropriate taxes withheld.
- Recruitment awards must be spent or returned to the ELRC by June 30th.
- Final Expense Reports will be due by July 31st.

Staff Employment Changes:

- Staff who have given notice when the program receives their payment, must be paid their award.
- Staff who have left employment prior to the receipt of award from the ELRC, provider may move those funds into the recruitment award to pay a sign on bonus for the staff replacement (cannot exceed number of recruitment slots).

Grant Closures:

- Once you have paid all retention and recruitment funds, please complete the Final Expense Report which you can download [here](#). Please complete ALL sections highlighted in yellow. Return the completed expense report to your Quality Coach.
- If you have to return funds because staff have left employment and/or you haven't been able to use the recruitment funds, complete the [Final Expense Report](#) and return the document with your payment to:

Rapid Response Team Tip of the Month FAQ



Will the Rapid Response Team get a child services with Early Intervention faster?

- No. RRT will not be able to move a child up a waitlist or make an evaluation occur faster. The RRT can assist in connecting families and providers with local supports and bridge the gap between the classroom and possible referrals to other services.

What types of referrals can be offered?

- Both the contracted observer and the Quality Coach are able to connect families and providers to local resources, as applicable, including Early Intervention, Intermediate Units, Behavioral Health Specialists, Developmental Pediatricians, IECMH and more!

Can the Rapid Response Team provide one-on-one supports to a child?

- The RRT is a short-term intervention designed to connect families and providers with existing community resources.

Does the Rapid Response Team work with my classroom staff?

- Yes! Your Quality Coach will complete an observation in the classroom and provide teachers with direct feedback and strategies to support the whole classroom.

Are there professional development opportunities for my staff?

- Yes! A community of practice meets monthly to give staff an opportunity to discuss challenges they are having, connect with other teachers, and get resources that they can use immediately in their classrooms. See our Community of Practice listing [here](#).

Dangers of Co-Sleeping

Co-sleeping, particularly bed-sharing, is dangerous because it significantly increases the risk of infant death from accidental suffocation, strangulation, entrapment, or Sudden Infant Death Syndrome (SIDS). Adult mattresses, pillows, and bedding can easily suffocate a baby, and sleeping adults may accidentally roll onto or trap an infant.



Why Co-Sleeping (Bed-Sharing) Is Dangerous:

- **Accidental Suffocation & Overlying:** An adult or older child can accidentally roll onto a baby, blocking their airway. Soft mattresses, waterbeds, couches, or heavy blankets can also cause suffocation, as babies cannot move away from these dangers.
- **Positional Asphyxiation:** Babies can become trapped between the mattress and a wall, headboard, or bed frame, or get into a "chin-to-chest" position that compromises their breathing.
- **Overheating:** Sharing a bed with an adult can lead to overheating, which is a known risk factor for SIDS.
- **SIDS Risk:** Studies strongly link bed-sharing with an increased risk of SIDS, particularly for infants under 4 months or those born preterm.

Safe Alternatives:

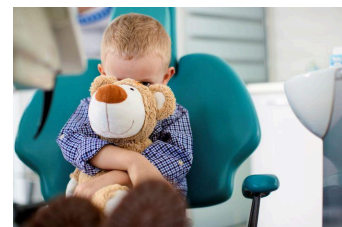
The American Academy of Pediatrics (AAP) recommends room-sharing without bed-sharing. Having the baby sleep in their own crib or bassinet within the parents' room reduces the risk of SIDS by up to 50%.

Oral Health for Children with Disabilities

A disability can affect a child's activities and ability to learn. Some children with disabilities need extra health services and support services. Children with disabilities are at higher risk for tooth decay and other oral health problems than children without disabilities.



Oral Health Challenges for Children with Disabilities

- Children with physical disabilities, such as cerebral palsy, may not have the motor skills they need to use a toothbrush safely or to sit still in a dental chair during dental visits.
- Children with communication disorders, such as delayed speech and language development, may not be able to tell their parents that they have a toothache.

- Children who get frequent medical care, such as having many medical visits or hospital stays, may be afraid of the dental office and may not cooperate during visits.
- Children who take medicines with added sugars or that cause dry mouth are at high risk for tooth decay.
- Children on special diets may be at high risk for tooth decay. Foods that are soft or high in starch (e.g., potatoes, corn) stick to children's teeth and give bacteria in the mouth more time to cause tooth decay.

Strategies to Help Improve the Oral Health of Children with Disabilities

- Click [here](#) to learn more about taking care of teeth, selecting the right toothbrush, adapting toothbrushes, addressing challenges, providing good nutrition, encouraging safety, and going to the dentist.
- Give children with disabilities extra support. Make sure children eat food and drink beverages low in sugar and that children's teeth are brushed with fluoridated toothpaste after meals. Children with intellectual disabilities may need extra time for brushing.
