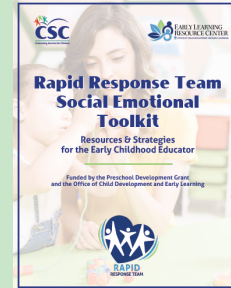

Rapid Response Team

****Update for the Rapid Response Team****

The Rapid Response Team provides prompt support in the event a child is at risk of suspension or expulsion. It is a short-term, collaborative approach, designed to connect families and providers with existing tools and resources. Supports are customized to fit a child's or teacher's needs.






Requests can be made using this [RRT Referral form](#). Referrals are processed on a first come, first served basis and we ask that providers prioritize one child referral at a time. One of the goals of the RRT is that strategies and supports will be used across classrooms at the provider so that all children and staff will benefit from these supports.

Before submitting a referral, please discuss with the parent as parental consent is required. Child observations, screenings, and parent conferences should also have been completed so that you can provide the referral coordinator with detailed information regarding the case.

CCW Reminders



Co-payment Delinquencies

- It is important to report delinquent CCW co-payments timely to the ELRC. Per Appendix A of the ELRC Certified Provider Agreement, providers must report a delinquent co-payment to the ELRC on the business day following the day the co-payment becomes delinquent. For

example, if a co-pay is not paid by Friday for that service week, the delinquency must be reported on your next business day, which is typically Monday.

- Please note, delinquencies can only be reported for co-payments. Delinquencies regarding additional fees your program charges must be handled privately with the family. If you are aware that a family is currently under adverse action, please urge them to resolve this as soon as possible in order to maintain their eligibility and prevent any disruptions in care.
- When delinquent co-pays are resolved, please notify us, or report on Provider Self Service, so we can satisfy the client's adverse action. When families are seeking to transfer enrollments, an ELRC Family Specialist will contact you to verify if that family is current with their co-payment before authorizing the transfer.

June Invoices

All providers must submit their June invoice no later than July 30th. While other months allow for a 60 day window to submit invoices, due to the close of the ELRC fiscal year, all invoices must be closed out by the end of July. Invoices received beyond July 30th may not be paid.

School Age Flip

The ELRC is preparing for the change in schedules for school-age children over the summer months. The school age flip from part-time to full-time for all eligible school age enrollments and eligible PKC and Head Start children, will take place on **June 15, 2026**.

You will receive an email from the ELRC with instructions on how to review and update your summer, anticipated attendance.



Child Care Staff Retention & Recruitment Grant - FER

All CCSRR grant requests have been paid out to providers.

Policy Reminders:

- Providers must pay retention awards to staff within 45 days of receipt of payment from the ELRC.
- Awards must be paid through payroll with appropriate taxes withheld.
- Recruitment awards must be spent or returned to the ELRC by June 30th.
- Final Expense Reports will be due by July 31st.

Staff Employment Changes:

- Staff who have given notice when the program receives their payment, must be paid their award.
- Staff who have left employment prior to the receipt of award from the ELRC, provider may move those funds into the recruitment award to pay a sign on bonus for the staff replacement (cannot exceed number of recruitment slots).

Grant Closures:

- Once you have paid all retention and recruitment funds, please complete the Final Expense Report which you can download [here](#). Please complete ALL sections highlighted in yellow. Return the completed expense report to your Quality Coach.
- If you have to return funds because staff have left employment and/or you haven't been able to use the recruitment funds, complete the [Final Expense Report](#) and return the document with your payment to:

Rapid Response Team Tip of the Month *Engaging Children with Social and Emotional Challenges*



- **Build Trust and Safety:** Children with social-emotional difficulties often need a predictable, safe environment where they feel heard and respected.
- **Creating a Safe and Nurturing Environment:** Establish a consistent daily routine, create a warm and welcoming atmosphere, and foster positive relationships between caregivers and children.
- **Encouraging Emotional Expression:** Provide opportunities for children to express their emotions in healthy ways, encourage open communication, and teach them emotion words.
- **Teaching Emotional Regulation:** Help children manage and respond to their emotions in a healthy way by creating a safe space, teaching them to use positive language, and using art and play as tools for emotional expression.
- **Support Social and Emotional Skills:** Incorporate social-emotional learning (SEL) strategies such as:
- **Emotion Labeling:** Help children identify and name feelings (How are you feeling?)
- **Role-Playing:** Practice social scenarios to build communication and conflict resolution skills.
- **Mindfulness and Regulation Tools:** Use breathing exercises, calming corners, or sensory activities to help self-regulate.
- **Promoting Empathy and Social Skills:** Encourage children to practice empathy and social skills through guided play, storytelling and role playing.
- **Addressing Challenging Behavior with Empathy:** Approach challenging behaviors with empathy, curiosity and care, and modeling emotional literacy and social-emotional learning.
- **Foster Relationships:** Encourage positive relationships with adults and peers. Pair children with supportive caregivers, use group activities that promote cooperation, and model respectful interactions. For children with attachment challenges, spend extra time building one-on-one connections.
- **Collaborate with Families:** Involve parents or guardians in understanding the child's behavior and in planning supportive strategies. Share observations, celebrate progress, and work together to create a cohesive approach between home and childcare.

Children Experiencing Homelessness

As the school year comes to a close, some children may be experiencing housing insecurity. Here are some strategies to help families over the summer months adjust to the changes in routine:

Plan for Summer Gaps

- Survey parents to ask about needs or concerns - food, clothing, diapers, formula, shelter/housing, etc.
- Reach out to community partners to determine where to refer families over the summer.

Prioritize Enrollment for Families Experiencing Homelessness

- Connect with the local educational agency for referrals of young children experiencing homelessness.
- Ensure that homeless families are prioritized for services per federal guidance.

Make Your Program Accessible

- Update enrollment forms and housing questionnaires to ask about living situations that may qualify as homeless.
- Translate information about homelessness into languages commonly spoken in your community.

Support Smooth Transitions to K-12

- Provide warm handoffs to school district homeless education liaisons.
- Share information to help school districts identify children and plan services.

The Child Adult Care Food Program (CACFP)

CACFP is a federal program, administered by the PA Dept. of Education, that provides reimbursements for nutritious meals and snacks to eligible children enrolled in participating child care centers and child care homes. In PA, only 36% of child care providers participate in this valuable program. If you are interested in participating or would like more information, check out the [PA Dept. 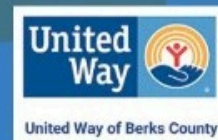
- A “[Fillable Proposal Application](#)”. This Word document must be completed and submitted as your proposal response

Summer Safety Tips

As the weather heats up, we can ensure a safe and fun summer with these practical tips:



Sunscreen

- Sunscreen must be provided by the parent and labelled with the child's name. Check for expiration dates too! It should be a broad-spectrum sunscreen of SPF 30 or higher to prevent sunburn.
- Apply at least 15-30 minutes before going outside.

Outdoor Safety

- Avoid outdoors between the peak hours of 10:00 AM - 4:00 PM. If you do go outside, seek a shady area or invest in shade structures for your playground.
- Use the [Child Care Weather Watch](#) to help decide if it is safe for children to be outside.

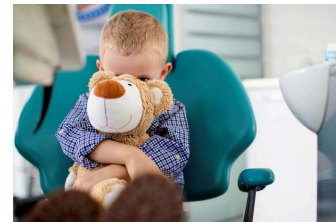
Hydration and Heat Exhaustion Prevention

- Provide frequent water breaks when outside during hot weather
- Make sure water is accessible at all times
- Encourage parents to send their children in light colored clothing

Communicating with Your Dentist

Before visiting a dentist, it is very helpful if a child's parent or guardian completes this form: [Getting to Know Me: Information for Your Child's Dental Office](#).



The form gathers information about the child's ability to cooperate during dental visits. It also includes suggestions about approaches that might work best for the child. This information will help the dental office staff understand and meet the child's needs.
