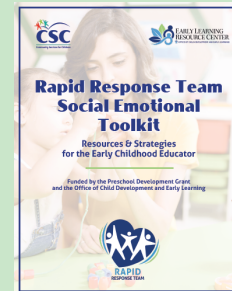

Rapid Response Team

*****Update for the Rapid Response Team*****

The Rapid Response Team provides prompt support in the event a child is at risk of suspension or expulsion. It is a short-term, collaborative approach, designed to connect families and providers with existing tools and resources. Supports are customized to fit a child's or teacher's needs.



Requests can be made using this [RRT Referral form](#). Referrals are processed on a first come, first served basis and we ask that providers prioritize one child referral at a time. One of the goals of the RRT is that strategies and supports will be used across classrooms at the provider so that all children and staff will benefit from these supports.

Before submitting a referral, please discuss with the parent as parental consent is required. Child observations, screenings, and parent conferences should also have been completed so that you can provide the referral coordinator with detailed information regarding the case.

Community of Practice

Monthly Communities of Practice are available to all program leadership and staff. These 30-minute sessions are held via Microsoft Teams and focus on helping program staff effectively utilize resources to strengthen the social and emotional climate of their classrooms using the Rapid Response Team Social Emotional Toolkit.

Join us this month to take a look at triggers that may cause children's challenging behaviors. CoP will be held on July 16th at 1:00 pm or 6:00 pm.

CCW Reminders



Outstanding Invoices

Providers must submit all outstanding invoices for May and June no later than **July 30th**. While other months allow for a 60-day window to submit invoices, due to the close of the ELRC fiscal year, all invoices must be received by 7/30. **Invoices received beyond 30th will not be paid.**

School Age Flip

The School Age Flip occurred on June 15. As a reminder, providers who have accepted the blended rate have been paid a higher part-time rate which includes 25 full-time days throughout the school year. This accounts for any gaps that may have occurred between your local school district end date and school age flip date.

Adverse Action Notification

When a family has become ineligible to continue with CCW funding, an Adverse Action (AA) is issued. Providers will also receive a copy of the AA. Please confirm receipt of this AA notification with the family and discuss next steps with them. You must wait to take action (change in fee collection, ending care, etc.) until the date on the notice, not the date the notice was received.

Payment Schedule 2026-2027

The CCW Payment schedule for 2026-2027 has been released. Please download a copy and take note of invoice due dates and payment dates.

CCSRR Grant - Final Expense Reports DUE!

All unspent funds from the CCSRR grant were due back to the ELRC by 6/30. If you have not returned funds, you are in non-compliance and should report this to your Quality Coach immediately.

Final Expense Reports must be returned **no later than July 31st**.

Rapid Response Team Tip of the Month

Biting in Young Children



Biting is a common behavior among toddlers and young 2-year-olds. While challenging for adults, most children outgrow it as they develop self-regulation skills and receive calm, consistent support.

Why Children Bite

- Exploring sensations and cause-and-effect.
- Communicating needs, frustration, anger, or discomfort.
- Imitating others.
- Coping with stress, changes in routine, or sensory needs.
- Acting impulsively due to limited self-regulation skills.

Prevention Strategies

- Maintain age-appropriate expectations.
- Create quiet spaces for children to regroup.
- Reduce crowding and provide adequate space.
- Keep routines predictable.
- Use positive guidance and teach appropriate behaviors.
- Offer safe sensory alternatives, such as cold washcloths.

When Biting Occurs

Respond calmly, support both children involved, and teach alternative ways to communicate and manage emotions. Practice these skills during calm moments.

If Biting Persists

Work collaboratively with families to identify patterns, triggers, and effective strategies. With consistent, developmentally appropriate support, most children learn safer ways to express their needs and feelings.

Keystone STARS Tip of the Month

STAR Movement

Summer months bring a good opportunity to focus on some goals you may have set for yourself over the school year. College students are back to help out, attendance can be lower with family vacations and older age groups are out of the facility taking part in fun field trips and excursions.

Use this time to work on your ERS self-assessments, begin organizing child files for the Fall, schedule staff to take some trainings on assessment tools or curriculum. If you set a goal to achieve the next STAR level this year, reach out to your Quality Coach who can help you access tools and resources to make the movement process smoother for you. Higher STAR level programs are able to receive a higher subsidy reimbursement amount, called a STAR add-on and may be eligible for higher grant amounts when grants become available this school year.

PD Registry App

The new PD Registry App is now available for Apple and Android devices, making it easier than ever for early learning professionals to manage their professional development on the go.

With the app, users can:

- Upload documents directly from their phone camera or files
- Access and manage their PD Registry anytime

The app is free to download in the App Store and Google Play. Designed with Pennsylvania early childhood educators in mind, this new tool helps save time so they can stay focused on what matters most—supporting children and families.



Annual Child Care Immunization Survey

The PA Department of Health (DOH) is sending out the **Annual Child Care Immunization Reporting Survey** to all licensed child care providers to meet the immunization reporting requirements outlined in **28 Pa. Code § 27.77 (a)(4) Immunization requirements for children in child care group settings**.

The DOH is asking that all licensed child care providers complete and submit the survey [Annual Child Care Immunization Survey 2026](#) by **August 31, 2026**.

The following resource materials have been provided to help with reviewing immunization records and completing the **survey**:

- Links to childhood immunization schedules from nationally recognized medical associations: **American Academy of Pediatrics, American Academy of Family Physicians, or American College of Obstetricians and Gynecologists**

All schedules include the same recommendations regarding childhood vaccinations:

- **Vaccine Identification document**

Immunization Tracking Worksheets

- **PA Child Care Reporting Worksheet Printable (PDF)**
- **DOH Child Care Tracking Worksheet (Excel)**

The tracking worksheets do not need submitted – they are only a tool to help you organize the information needed to complete the survey.

Preventing Children from Being Left in Vehicles

Every year, children are injured or lose their lives after being left in hot vehicles. Even on mild days, the temperature inside a parked car can rise rapidly, creating life-threatening conditions within

minutes. Both child care providers and parents play a critical role in preventing these tragedies.

Strategies for Child Care Providers

To ensure children are safe during summer field trips or other outings, establish clear transportation procedures for every trip.

- Conduct a head count before departure, upon arrival, and before leaving the vehicle. Use a written attendance log and verify that every child has been accounted for.
- Perform a thorough vehicle check after each trip. Walk to the back of the vehicle and inspect every seat, including under blankets and behind seats.
- Consider placing a reminder item, such as a clipboard, attendance sheet, or staff bag, in the rear of the vehicle so drivers must walk through the entire vehicle before exiting.
- Train all staff on transportation safety policies and emergency procedures. Create a culture of accountability where staff members remind and support one another in following safety protocols.

Support parents in developing these habits as well. Schedule daily attendance checks and immediately follow-up when a child expected at the program does not arrive. Post or distribute helpful flyers like this one:

CDC Issues Recall for Infant Formula: ***Infant Botulism Outbreak Linked to Powdered Infant Formula***

The Centers for Disease Control and Prevention (CDC) has issued a recall for powdered infant formula.

On June 13, 2026, Nara Organics recalled all Nara Organics Whole Milk Organic Infant Formula. Nara Organics infant formula is a powdered formula sold at Target retail stores, Target.com, and Nara.com.

Per the CDC, please follow the following instructions:

Do not use recalled infant formula. If you have unopened cans of Nara Organics infant formula, throw them away or return them. If you have an opened can of Nara Organics infant formula, see guidance from the CDC.

Wash items and surfaces. Wash items and surfaces that may have touched the recalled formula using hot soapy water or a dishwasher.

Seek care if your infant becomes ill. Seek immediate medical care if your infant consumed Nara Organics infant formula and has any of these signs or symptoms of infant botulism: poor feeding, loss of head control, difficulty swallowing, or decreased facial expression.

Report information to the FDA. To report a complaint or adverse event (illness or serious allergic reaction), visit the FDA's Safety Reporting Portal. If your child has signs or symptoms of infant botulism, seek medical attention **before** using the portal.

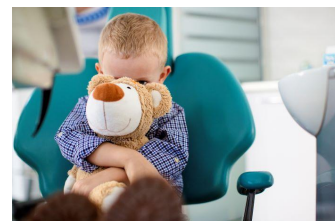
Tick Safety

What should childcare providers do when they find a tick on a child?

Department of Human Services Certification recommends that if a childcare provider finds an embedded tick, they should immediately contact the child's parent or guardian so that next steps can be determined quickly. This is consistent with regulation 132(a). It is advised that a provider does not remove a tick unless there is written authorization by the parent and the provider has received the appropriate health and safety training to do so. Following proper technique for tick removal can be challenging; even with proper technique, heads can stay attached and need to be dug out, which can be difficult.

Oral Health Tip ***Finding a Dentist***

Did you know that tooth decay is the number one chronic disease for children but can be prevented and managed with good oral care? Oral care starts during pregnancy, and dental visits should begin by a child's 1st birthday.
